

## TABLEAU ALPHA/BETA SOFTWARE LICENSE AGREEMENT

By downloading, accessing, installing, copying and/or using any Tableau software product provided as test, pre-release, pilot or alpha, beta or similar (“Alpha/Beta Software”), the individual or entity taking such action (“you”) agrees to be bound by the terms of this License Agreement (“License”). Accessing or using the Software does not entitle you to any compensation or future rights. Your use of the Alpha/Beta Software is also subject to the End User License Agreement, Master Services Agreement or other terms that are otherwise applicable to Tableau software products. The Alpha/Beta Software is licensed to you by Salesforce, Inc., or its applicable affiliate as identified in such terms (“Salesforce”). In the event of a conflict between such terms and this License, this License will control.

- 1. PURPOSE.** The Alpha/Beta Software is provided solely for testing and evaluation. You may not use it for any other purpose.
- 2. SOFTWARE LICENSE.** Subject to your compliance with the terms and conditions of this License, including Section 3, Salesforce grants you a limited, non-exclusive, non-transferable, non-assignable, non-sublicensable license, during the Alpha/Beta Period, to use the Alpha/Beta Software solely for testing and evaluation as described in this License.
- 3. RESTRICTIONS.** You will not: (a) remove, alter, or obscure any proprietary notices (including copyright notices) on the Alpha/Beta Software; (b) modify the Alpha/Beta Software, merge it with any other software, or reverse engineer, decompile, disassemble or otherwise attempt to discover its source code; (c) rent, transfer or otherwise distribute any copies (or portions thereof) to a third party, allow a third party to use the Alpha/Beta Software, or make its functionality available to the public in any manner; (d) use the Alpha/Beta Software to develop services or products for sale or include any components in any product; (e) use any portion of the Alpha/Beta Software to create a competitive service, product or technology; (f) use the Alpha/Beta Software for production purposes or any other purpose other than as expressly permitted; or (g) register, prosecute or otherwise obtain any intellectual property rights in the Alpha/Beta Software or derivatives, or attempt to do any of the foregoing.
- 4. RESERVATION.** All rights not expressly granted in Section 1 are reserved by Salesforce and its suppliers (including, without limitation, all intellectual property rights). No other rights are granted, whether by implication, estoppel or otherwise.
- 5. CUSTOMER TESTING AND FEEDBACK.** You will test the Alpha/Beta Software during the Alpha/Beta Period. You may provide suggestions, comments, usability, bug reports and test reports and other feedback (“Feedback”) to Salesforce with respect to the Alpha/Beta Software. Feedback, even if designated as confidential, will not, absent a separate written agreement, create any confidentiality obligation for Salesforce. You will not give Feedback that is subject to license terms that seek to require any Salesforce product, technology, service or documentation incorporating or derived from such Feedback, or any Salesforce intellectual property, to be licensed or otherwise shared with any third party. You hereby assign to Salesforce all rights in any Feedback you provide. You acknowledge that Salesforce will be free to use, disclose, reproduce, license or otherwise distribute, and exploit the Feedback provided to it as it sees fit, entirely without obligation or restriction of any kind on account of intellectual property rights or otherwise. All copies, improvements, updates, modifications or enhancements of the Alpha/Beta Software will remain the property of Salesforce (including any changes which incorporate any Feedback).
- 6. NO MAINTENANCE.** Salesforce will not provide any support or maintenance for the Alpha/Beta Software. This License does not entitle you to future releases or updates.
- 7. CONFIDENTIALITY.** The Alpha/Beta Software constitutes valuable trade secrets of Salesforce and its suppliers. You will not disclose Confidential Information to any third party. “Confidential Information” means: (a) information about the Alpha/Beta Software, including its design, performance characteristics,

or any communications with Salesforce relating to the Alpha/Beta Software, (b) object code, source code, architecture, algorithms, techniques, formulas, processes, know-how, ideas, inventions (whether or not patentable or copyrighted), and specifications and characteristics of products or services planned or being developed, (c) Feedback (including bug reports and test results), or (d) any other information marked as confidential or proprietary or that should be reasonably understood to be confidential or proprietary that is received from Salesforce or discovered by you in the performance of this License whether or not relating to the Alpha/Beta Software. Confidential Information does not include information that (a) was rightfully in your possession or known to you prior to receipt of the Confidential Information, (b) is or becomes publicly available without breach of this License, (c) becomes available to you on a non-confidential basis from a source other than Salesforce, provided that such source is not bound by a confidentiality agreement with respect to such information or (d) is independently developed without use of any Confidential Information as documented by written evidence. You will use reasonable efforts to protect and prevent any access to the Alpha/Beta Software or other Confidential Information. All Confidential Information will remain the property of Salesforce. You acknowledge that unauthorized disclosure of Confidential Information would cause substantial harm for which damages alone would not be a sufficient remedy, and therefore that upon any such disclosure Salesforce will be entitled to appropriate equitable relief in addition to whatever other remedies it might have. Any disclosure of Alpha/Beta Software or other information by Salesforce pursuant to this License does not, in itself: (a) create warranties or representations of any kind; (b) create a commitment as to any product, service, product feature or functionality, or prospective business relationship or (c) constitute solicitation of any business or the incurring of any obligation not specified in this License.

- 8. Usage Data.** You agree that Salesforce may collect, store, aggregate and otherwise use any of your metadata, statistical data, log/crash data, registration data and/or other usage data relating to the Alpha/Beta Software. You acknowledge that Salesforce may use any such data for its own internal business purposes, including: (a) for its own internal, statistical analysis, (b) to develop and improve the Alpha/Beta Software or other products or services; and/or (iii) to create and distribute reports and other materials regarding the Alpha/Beta Software.
- 9. WARRANTIES.** THE ALPHA/BETA SOFTWARE IS PROVIDED "AS IS" AND WITH ALL FAULTS. SALESFORCE MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND WITH RESPECT TO THE ALPHA/BETA SOFTWARE, WHETHER EXPRESS, IMPLIED, OR STATUTORY, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, NON-INFRINGEMENT, ACCURACY, INTERFERENCE WITH YOUR QUIET ENJOYMENT, SYSTEM INTEGRATION OR WARRANTIES ARISING FROM COURSE OF DEALING, USAGE, OR TRADE PRACTICE. You acknowledge that the Alpha/Beta Software may not be complete or fully functional and may contain bugs, errors, omissions and other problems that could cause system or other failures and data loss. You acknowledge that Salesforce has no express or implied obligation to you to make the Alpha/Beta Software available or operational, to maintain or correct errors in the Alpha/Beta Software, or to announce or publicly introduce a production version of the Alpha/Beta Software. Accordingly, you acknowledge that any use of the Alpha/Beta Software is done entirely at your own risk.
- 10. LIMITATIONS OF LIABILITY.** IN NO EVENT WILL SALESFORCE OR ITS AFFILIATES BE LIABLE TO YOU OR ANY THIRD PARTY FOR THE COST OF PROCUREMENT OF SUBSTITUTE SOFTWARE OR SERVICES, LOST PROFITS, LOST DATA, OR ANY SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL OR PUNITIVE DAMAGES OF ANY KIND, HOWEVER CAUSED AND ON ANY THEORY OF LIABILITY ARISING IN ANY WAY OUT OF THIS LICENSE OR YOUR USE OF OR INABILITY TO USE THE ALPHA/BETA SOFTWARE, EVEN IF SALESFORCE OR ANY OF ITS AFFILIATES HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THE TOTAL CUMULATIVE LIABILITY RELATED TO THIS LICENSE OF SALESFORCE AND ITS AFFILIATES SHALL BE LIMITED TO FIFTY DOLLARS (U.S. \$50). THE LIMITATIONS SPECIFIED IN THIS ARE A FUNDAMENTAL PART OF THE BASIS OF THE BARGAIN BETWEEN THE PARTIES AND WILL SURVIVE AND APPLY EVEN IF ANY LIMITED REMEDY SPECIFIED IN THIS LICENSE IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

- 11. PERSONAL INFORMATION.** In connection with your installation, registration and use of the Alpha/Beta Software, Salesforce receives information that you provide during the installation or registration process, as well as your usage information and automatically-collected computer configuration information. The Salesforce Privacy Statement (located at [www.salesforce.com/company/privacy](http://www.salesforce.com/company/privacy)) applies to the collection of that information.
- 12. TERM AND TERMINATION.** This License commences upon the date you download, access or use the Alpha/Beta Software, or the date Salesforce delivers it to you, whichever is earlier, and will continue in effect until the end of the specified test period, unless sooner terminated as provided herein (“Alpha/Beta Period”). If no time period is designated, then the License shall automatically expire after 60 days or when access is automatically removed. Either party may terminate this License upon written notice to the other party. Upon any termination or expiration, the rights granted to you will automatically cease, you will immediately cease all use of, and delete or destroy (or return, if requested) all copies of the Alpha/Beta Software and other Confidential Information of Salesforce in your possession or control. Sections 1, 3, 4, 5, 6, 7, 8, 9, 10, 11 12 and 13 will survive any expiration or termination.
- 13. GENERAL PROVISIONS.** Nothing in this License obligates either party to enter into any further agreement with the other party. This License will be governed by the laws of the State of Washington without regard to its conflicts of laws rules. The parties submit to the exclusive jurisdiction and venue of the federal and state courts for King County, Washington, for any disputes arising out of or related to this License. Salesforce may assign or transfer any of its rights under this License without restriction. You may not assign or transfer, by operation of law or otherwise, any of your rights under this License to any third party without Salesforce’s prior written consent. Any waiver or failure to enforce any provision of this License on one occasion will not be deemed a waiver of any other provision or of such provision on any other occasion. Salesforce may terminate this License and seek injunctive relief upon any breach or threatened breach, without the need to post any bond or security. If any part of this License is found void and unenforceable, it will not affect the validity of the balance of this License, which will remain valid and enforceable according to its terms. The parties are independent contractors and no relationship of employment, agency or joint venture is created under this License. This License is the final, complete and exclusive agreement between the parties relating to the subject matter hereof, and supersedes all prior or contemporaneous understandings and agreements relating to such subject matter, whether oral or written.
